Assistance in the complex processes that have to do with opening bank accounts as well as support and definition of the best procedures for international banking.

Creation of agile mechanisms for signature of documents by parent companies that have to report to Supervisory entities in the countries of origin.

Evaluation of the needs of the Regulator, in the Company's Country of origin.

Creation of transparency mechanisms at the level of the Tax and Customs Authority, as well as at the level of Social Security, in the relations with the Administration and the technical staff that will be placed in Portugal.

Active search for support from the government and public institutes to subsidize or grant subsidized interest rates for job creation or direct investment in productive structures.

Interaction with the existing chambers of commerce in each country as well as with the foreign investment agencies either through the Portuguese agency AICEP, or through other local entities such as KOTRA, in South Korea, and its Delegations.

In recent times, we have had an effective and progressively larger presence in the Southwest Asian market, with special relevance for the South Korean Japanese market, representing in Portugal companies owned by one of the largest South Korean textile companies with a global dimension, listed on the Seoul Stock Exchange.

This last insertion has meant a great effort to adapt to an extremely rich reality such as South Korean society, having provided us with an extremely enriching global immersion that has passed through gastronomy, filmography, and health trips in order to find the right sense of the best collaboration between our office and our clients in this geography.
